

Juneteenth JoyFest Vendor Agreement

Event Details: Juneteenth JoyFest- Black Arts & Culture Festival

Date: Saturday June 15th, 2024

Time: 12pm-10pm

Location- N. 24th St (entrance at 22nd & Ohio) *exact set up details will be sent by 06.07.24

Admission: Free or donation-based

Estimated Attendance- Juneteenth JoyFest approximate attendance for 2023 was 1000+ throughout the day. Our expected attendance this year is around 1000-1200 throughout the day.

The agreement serves to communicate JJF policies for participating vendors. Participating vendors should carefully read the enclosed information.

Terms & Agreement

- 1. Participating vendors agree to remit payment to Juneteenth JoyFest as follows a. The Vendor fee is to participate for the June 15th, 2024 festival.
- 2. Participating Vendors agree to remit a **nonrefundable** vendor fee cost of \$80.00 no later than **April 20th**, **2024**, **no exceptions**.
- 3. Vendors agree to the allotted space of 1 table per vending booth. Booth size is (10' x 10') (standard folding table 96" x 30") or two small folding tables (24" x 48") per vendor fee.
- 4. If a Participating vendor would like space for more than one standard-size table, or two small tables, they must pay an additional vendor fee (\$75) per standard table or small-size table.
- 5. Vendors are **required to have a standard canopy and table at this event**. Vendors can rent a canopy and/or table for this event from Juneteenth JoyFest.
- 6. Juneteenth JoyFest will provide 1 chair. Any additional chairs must be provided by vendor or can be rented with a table rental.

By filling out the vendor application form, you agree to these Black Flea Market vendor terms.

- 7. Rental Options for Juneteenth JoyFest are:
 - a. 1 Standard Canopy Rental- \$75.00
 - b. 1 Standard Table & 1 additional chair Rental- \$25.00
- 8. If Participating Vendors **rent** vending equipment from Juneteenth JoyFest and can no longer make the event, **all renting equipment fees are nonrefundable.**
- 9. Participating Vendor spots will not be **secured** until vendor cost is paid to Juneteenth JoyFest. (Payment due 04/20/24)
- 10. Participating Vendors are responsible for having the **required licenses and permits** needed to sell their products. (i.e. food vending, alcoholic beverages, baked goods, etc.)
- 11. Participating Vendors agree to set up for the Black Flea Market between **8-10** am on Saturday, **June 15th, 2024.**
- 12. Participating vendors agree to bring all items needed for vending, i.e. table, chairs, etc, unless otherwise rented from Juneteenth JoyFest.
- 13. Electricity is limited. Vendors must provide their source of power if needed for their setup.
- 14. This is a family-friendly festival, all vending items must be appropriate and **legal.**
- 15. Vendors are required to submit vendor economics data to JJF after the event. (Amount of profit, needed for future development of the Festival)
- 16. Juneteenth JoyFest is not liable for any damaged, stolen, or lost goods.

 Participating vendors agree to take full responsibility for vending, personal, and merchandising items. Juneteenth JoyFest encourages participating vendors to have liability insurance for their protection.

IN SUMMARY:

- You agree to indemnify, protect, defend, and hold harmless, the sponsors, proprietors, of the location and all of its associates for any personal injury, loss, or damages of any nature suffered by any persons, vendors, and especially attendees while within the vendor's space or caused by the vendor.
- Agree to hold harmless the sponsors, proprietors of the location, and its associates for any merchandise lost, stolen, or broken.
- Agree that should an accident occur within the vendor's space, caused by the vendor's displays, products, or unsafe conditions, the vendor will be held liable.
- Agree with all of the rules and regulations in this contract.
- Juneteenth Joyfest reserves the right to apply new rules and regulations for the safety and quality of the Festival.
